

LAST WILL AND TESTAMENT
OF
JIM SMITH

I, Jim Smith, residing at 123 Main Street, San Francisco, CA, 91011 declare that this Last Will and Testament ("Will") is my will. I revoke all previous wills and codicils.

Section 1: Marital Status

I am married to June Smith, who is referred to in this Will as my Spouse.

Section 2: Children

I have the following living children:

John Smith, DOB: 2003-12-13

Alex Smith, DOB: 1995-03-31

Jessica Smith, DOB: 1998-11-01

If I have other children that are born or adopted after I create this Will, then they shall be included and share in proportion to the children named above. If I fail to include any child who was born or adopted at the time I created this Will, then this omission is intentional.

Section 3: Guardian

I nominate Jonathan Burke as Guardian to care for John Smith and their property. I understand that if my preferred Guardian is unwilling or unable to serve, that a court shall appoint one.

I nominate Heather Shaw as Guardian to care for Jessica Smith and their property. I understand that if my preferred Guardian is unwilling or unable to serve, that a court shall appoint one.

Section 4: Will Agent

I name Colan Holmes to serve as my Will Agent. The term "Will Agent" means my personal representative, executor or administrator of my estate. I direct my Will Agent to take all legal actions to probate this Will as simply as possible and act as free of court supervision as allowed under applicable laws, including filing a court petition to independently administer my estate. I understand that if my preferred Will Agent is unwilling or unable to serve, that a court will appoint one.

My Will Agent is granted broad authority regarding the execution of my Will. This shall

include, but not limited to, decisions to pay, refuse to pay, buy, sell, trade, invest, transact, vote, participate, abandon or take any other necessary action in order to fulfill the terms of this Will.

My Will Agent's authority shall apply to all possessions in and dealings with my estate such as real estate, stock, personal property, business ventures, legal claims, debts, taxes, provided those actions further the best interests of my estate and beneficiaries and are not against any interest that I have specifically stated in this Will. These powers may be exercised as often as necessary or advisable, without application to or approval by any court.

My Will Agent shall not be required to post bond.

My Will Agent shall be reimbursed for all reasonable expenses incurred in executing my will.

Section 5: Distribution of Property

My Will Agent shall distribute my estate according to the following instructions.

I leave 100 percent of the real estate located at 123 Main Street, San Jose, CA 95052 to Spouse.

I leave 2004 GMC Canyon to Alex Smith.

I leave 2012 Ford F-250 to Jessica Smith.

I leave 2000 Lincoln Continental to Mark Smith.

I leave our Cat(s) Sweet Pea and \$4500 to care for it to Alex Smith.

I leave our Fish Goldilocks and \$500 to care for it to June Smith.

I leave Grandma Smith's gold watch, with inscription that says "yours forever" to Kelly Smith.

I leave Silver 2006 Harley Davidson Fatboy to John Smith.

I leave Dining room furniture, including table, 8 chairs, place mats to Mark Smith.

I leave Large Panasonic HDTV located in family room to Jessica Smith.

I leave Gold Cartier watch with leather strap to June Smith.

I leave Black leather sofas (one 3-seater, one 2-seater) to John Smith.

I leave Mahogany grandfather clock valued at \$25,000 to Kelly Smith.

I leave Fender electric guitar with amplifier and cables to Rob Jones.

I leave Black Kawai grand piano valued at \$30,000 to Jessica Smith.

I leave White gold wedding ring with diamonds, valued at \$12,000 to Kelly Smith.

I leave the rest of my estate, everything I own at my death that is subject to this Will and not specified above to Divide Equally Among My Children.

Section 6: Applicable Law

The validity and construction of my Will will be determined by the laws of California.

Section 7: Severability

If a court finds that a provision of this Will is not valid, the remaining portions of the Will shall remain valid, and any portions that can be executed, without reference to the invalidated portion, shall remain in effect.

Section 8: Signatures

I, Jim Smith, declare that I sign and execute this document as my last will and testament and further declare that I sign it willingly, that I execute it as my free and voluntary act. I declare that I am eighteen years of age or older, of sound mind, and under no constraint or undue influence.
